

Election Security Measures Voted on by David Martin and the Michigan House, 2021-22

Senate Bills 303-304 (David voted YES, Governor Whitmer VETOED)

Requires Michigan residents to present their voter IDs or verify their voter registration record in order for their vote to count.

House Bill 5253 (David voted YES)

Prohibits third-party money (“Zuckerbucks”) from being used to help conduct an election.

House Bill 5268 (David voted YES)

Prohibits election officials from sending unsolicited absentee voter ballot applications.

House Bill 4838 (David voted YES, Governor Whitmer VETOED)

Prohibits voting machines and electronic poll books from being connected to the internet during the tabulation of votes.

House Bill 4491 (David voted YES)

Ensures the integrity of the state’s Qualified Voter File is maintained by allowing local clerks to remove deceased voters.

House Bills 4127-28 (David voted YES, Governor Whitmer VETOED)

Clarifies uncertain dates of birth and removes people from the voting roll who have not voted in the past 20 years.

House Bill 4129 (David voted YES)

Requires a list of local clerks who are not current on continuing election training to be posted on the Secretary of State’s website.

House Bill 4132 (David voted YES)

Requires that a person who knowingly filled out and submitted an absentee ballot application using another person’s name and personal ID information would be guilty of a felony.

House Bill 4837 (David voted YES, Governor Whitmer VETOED)

Prohibits any non-accredited election official or organization from accessing the Qualified Voter File.

House Bill 4840 (David voted YES)

Requires that applications, ballots, and electronic poll book software must all be retained for 22 months after an election.

House Bills 4200, 5252 (David voted YES)

Requires the Secretary of State to review and post petition information on their website in a timely manner.

House Bill 4528, 6124 (David voted YES, Governor Whitmer VETOED 4528)

Would require training for poll challengers.

House Bill 4132-33 (David voted YES)

Would establish permanent absentee voter lists for clerks.

House Bill 5007 (David voted YES, Governor Whitmer VETOED)

Would provide a free photo ID for a wide range of applicants, so there are no roadblocks for every voter to obtain a photo ID.

House Bill 4876 (David voted YES)

Requires election workers to sign an affidavit to indicate their party affiliation.

House Bill 5253 (David voted YES)

Prohibits gifts to election officials from a third party.

House Bill 4897 (David voted YES)

Allows for election challengers to be present in the clerk's office and satellite absentee voting locations on Election Day.

House Bill 4492 (David voted YES, Governor Whitmer VETOED)

Would allow for more polling locations to be used during elections.

House Bill 4845 (David voted YES)

Signature verification training for local clerks, to ensure voters' signatures match the signature on file.

House Bill 5288 (David voted YES)

Prohibits insecure electronic signatures from being used on absentee ballots.

House Bill 4996 (David voted YES)

Requires the governor to promptly announce the timing of special elections.

House Bill 4132-33 (David voted YES)

Makes it a crime to provide false information on an absentee ballot.

House Bill 4134 (David voted YES)

Would allow for more voters to be included in a precinct.

House Bill 4135 (David voted YES)

Requires separate absentee voter counting boards for each local municipality.

House Concurrent Resolution 5 (David SUPPORTED)

Reaffirms a state's right under the U.S. Constitution to establish election laws and denounces the federal government's attempt to overreach into state election administration with HR 1.
